

BY-LAW NUMBER 60 (1970)

THE CORPORATION OF THE

TOWN OF PELHAM

BEING A BY-LAW TO PROVIDE FOR  
THE ISSUING OF LICENCES AND THE  
PAYMENT OF FEES THEREFORE FOR  
THE HUNTING OF PHEASANTS,  
RABBITS AND FOXES WITHIN A  
PART OF THE TOWN OF PELHAM.

WHEREAS by the Game and Fish Act 1961-62, Chapter 48, Section 37, it is provided that the Minister of Lands and Forests, may in writing authorize any municipality to pass by-laws for the issuing and fixing the maximum number of licences to hunt, during the open season pheasants, rabbits and foxes and for charging such fees therefor as he authorizes, and the said Minister may fix the minimum number of such licences that the by-law shall provide for:

AND WHEREAS By-law #57 of the Town of Pelham prohibits or regulates the discharge of firearms in that part of the Town of Pelham therein defined;

AND WHEREAS by Subsection 2 of Section 37 of the said Game and Fish Act, where a municipality has passed a by-law under subsection 1 of Section 37, no person shall hunt pheasant, rabbit or fox in the municipality during open season without a licence from the municipality;

AND WHEREAS the Council deems it advisable to pass a by-law to issue licences to hunt during the open season pheasants, rabbits and foxes and to prohibit unlicensed persons from hunting pheasants, rabbits or foxes in the portion of the Town of Pelham where the discharge of firearms is not prohibited by said by-law number 57.

NOW THEREFORE COUNCIL OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:-

1. The Town Treasurer is hereby appointed to issue licences to hunt pheasants, rabbits and foxes in the Town of Pelham excepting those portions of the Town described in by-law #57.

2. The said Treasurer may issue licences to individuals applying for the same for the hunting of pheasants, rabbits and foxes during the open season proclaimed upon payment to him, of the fees as hereinafter set out:

a) Non-residents of the Town of Pelham  
Licence fee \$2.00 Training fee \$ 20

3. The said Treasurer shall not in any year offer or provide for sale less than 350 non-resident licences.

4. a) The Council of the Town of Pelham may in each year by resolution enter into an agreement with one or more municipalities where by a licence to hunt pheasants, rabbits or foxes in the adjoining municipality shall be accepted on a reciprocal basis as a licence issued by the Town of Pelham.

b) No person shall hunt pheasants, rabbits or foxes within the Town of Pelham without a licence issued by the Town of Pelham under paragraph 2 here of or a licence issued by an adjoining municipality with which a reciprocal arrangement is made pursuant to paragraph 5 (a) here of.

6. The licence fees shall be paid to the <sup>TOWN #2.</sup> ~~City~~ Treasurer and at the discretion of Council, 50% of the fee may be distributed by resolution, each year, among the hunting and game associations within the Town of Pelham for the propagation of pheasant, conservation and the advancement of safety precautions among hunters.
