WHEREAS by a deed registered in the Registry Office for the Registry Division of Niagara South on the 8th day of May, 1980 as instrument no. 353906, the Roman Catholic Episcopal Corporation of the Diocese of Toronto in Canada conveyed to the Corporation of the Town of Pelham certain lands and premises, being parts 1, 2 and 3, Plan 59R-2647.

AND WHEREAS the said conveyance was subject to the retention by the grantor to the benefit of its successors and assigns of certain restrictive covenants as more particularly set out in the said deed.
