

THE CORPORATION OF THE

TOWN OF PELHAM

Being a by-law to establish Polling Subdivisions in the Town of Pelham.

WHEREAS it is necessary and expedient to establish Polling Subdivisions for the Town of Pelham

THEREFORE the Council of the Town of Pelham enacts the following areas to be known as Polling Subdivisions of the Town of Pelham in Wards 1, 2 and 3 as defined by the Regional Municipality of Niagara Act.

WARD #1

Polling

Subdivision #1: Consisting of all lands bounded on the north by the boundary of the Town of Pelham, on the east by the Town of Pelham, on the south by Sixteen Road and on the West by Cream Street North (Lots 1 to 11 inclusive in Concessions 1, 2 and 3).

Polling

Subdivision #2: Consisting of all lands bounded on the north by the boundary of the Town of Pelham, on the east by Cream Street North, on the South by Tice Road and on the West by the boundary of the Town of Pelham (Lots 12 to 20 inclusive in Concessions 1, 2, 3, 4, 5 and 6)

Polling

Subdivision #3: Consisting of all the lands bounded on the north by Tice Road, on the east by Balfour Street North and South, on the south by Foss Road and on the West by the boundary of the Town of Pelham except the lands in the Police Village of Fenwick (Lots 14 to 20 inclusive in Concessions 7 and 8, part of Lots 15, 16 and 17, and Lots 18 to 20 inclusive, Concessions 9 and 10).

Polling

Subdivision #4: Consisting of all the lands in the Police Village of Fenwick.

Polling

Subdivision #5: Consisting of all the lands bounded on the north by Tice Road, on the east by Centre Street, on the south by Foss Road and on the west by Balfour Street (Lots 10, 11, 12 and 13 inclusive in Concessions 7, 8, 9 and 10).

Polling

Subdivision #6: Consisting of all lands bounded on the North by Foss Road, on the east by Cream Street, and the south by the Welland River and on the west by the boundary of the Town of Pelham (Lots 12 to 20 inclusive in Concessions 11, 12, 13 and 14).

WARD # 2

Polling

Subdivision #1: Consisting of all the lands bounded on the north by Sixteen Road, on the east by the boundary of the Town of Pelham, on the south by Tice Road and on the west by Cream Street North (Lots 1 to 11 inclusive in Concessions 4, 5 and 6)

Polling

Subdivision #2: Consisting of all the lands bounded on the north by Tice Road, on the east by Effingham Street, on the south by Foss Road and on the west by Centre Street (Lots 6 to 9 inclusive in Concessions 7, 8, 9 and 10).

Polling

Subdivision #3: Consisting of the lands bounded on the north by Tice Road, on the east by Haist Road North and South, on the south by Hillcrest Road and on the west by Effingham Street except the lands in the Village of Fonthill (Lots 3, 4 and 5 inclusive in Concessions 7 and 8)

Polling

Subdivision #4: Consisting of the lands in the Village of Fonthill, bounded on the north by the Village boundary, on the east by the line between Lots 1 and 2, Concession 7, on the south by Canboro Road to the western boundary of the Village and on the west by Haist Road North. The lots on the east side of Pinecrest and the lots on both sides of Spencer Street are included in this poll.

Polling

Subdivision #5: Consisting of the lands in the Village of Fonthill bounded on the north by the Village boundary, on the east by Pelham Street North, on the south by Canboro Road and on the west by the line between Lots 1 and 2, Concession 7.

Polling

Subdivision #6: Consisting of the lands bounded on the north by Hurricane Road, on the east by the former east limit of the Village of Fonthill, on the south by Canboro Road East (#20 Highway) and on the west by Pelham Street North. (For information purposes only, Parkdale Subdivision is included in this poll)

Polling

Subdivision #7: Consisting of the lands bounded on the north by the Hydro Right of Way - crossing lots 160 to 163 inclusive of the former Township of Thorold, on the east by a line 660 feet measured at right angles from the eastern limit of Rice Road on the south by Hurricane Road and on the west by North Pelham Street.

WARD # 3

Polling

Subdivision #1: Consisting of the lands in the Village of Fonthill bounded on the north by Canboro Road, on the east by Highland Avenue and in a line between Lots 1 and 2, Concession 8, on the south by the rear lot lines of the lots that face the south side of Damude Drive and on the west by Haist Road South. Lots 1 to 9 inclusive of Plan 33 (Terrace Heights) are included in this Poll.

Polling

Subdivision #2: Consisting of the lands bounded on the north by Canboro Road, on the east by Pelham Street South on the south by the boundary of the Village of Fonthill and on the west by Highland Avenue and the line between Lots 1 and 2, Concession 8, except the lots in Terrace Heights.

Polling

Subdivision #3: Consisting of the lands bounded on the north by Canboro Road (#20 Highway) on the east by the eastern boundary of the Village of Fonthill, on the south by Port Robinson Road and on the west by Pelham Street South.

Polling

Subdivision #4: Consisting of the lands bounded on the north by Hillcrest Road, on the east by Haist Road to Welland Road and east along the unopen road allowance between Concessions 9 and 10 - Lots 1 and 2, to Pelham Street South and by Pelham Street South, and on the south by Foss Road and on the west by Effingham Street, (Lots 3, 4 and 5 in Concession 9 and Lots 1 to 5 inclusive in Concession 10).

Polling

Subdivision #5: Consisting of the lands bounded on the north by the southern limit of the Village of Fonthill, on the east by Pelham Street South, on the south by the unopened road allowance between Concessions 9 and 10 and on the west by Haist Road South, (Parts of Lots 1 and 2, south of the Village of Fonthill boundary in south of the Village of Fonthill boundary in Concession 8, and Lots 1 and 2 in Concession 9).

Polling

Subdivision #6: Consisting of the lands in the former Township of Thorold annexed to the Town of Pelham, bounded on the north by Canboro Road (#20 Highway), on the east by a line 660 feet east of Rice Road measured easterly at right angles from the east limit of Merritt Road and on the west by Pelham Street South and the former boundaries of the Village of Fonthill.


Polling

Subdivision #7: Consisting of the lands bounded on the north by Foss Road, on the east by Murdock Street, on the south by the Welland River and on the west by Cream Street, (Lots 2 to 11 inclusive in Concessions 11, 12, 13 and 14)

Polling

Subdivision #8: Consisting of the lands in the former Township of Thorold annexed to the Town of Pelham bounded on the north by Merritt Street, on the east by a line 660 feet east of Rice Road measured easterly at right angles from the east limit of Rice Road on the south by the northern half of lots on the 174, 175 and 176 to Line Avenue, all Lot 177 and that part of Lot 237 annexed to the northern limit of the City of Welland and on the west by Pelham Street South.
