

THE CORPORATION OF THE
T O W N O F P E L H A M
BY-LAW #683 (1981)

Being a by-law to amend By-law #535 (1979) -
being a by-law to regulate and govern the
installation of watermains, water services,
water meters and remote readers in all areas
of the Town of Pelham, and to fix rates and
charges for the installation of same and for
the water thereby supplied, and to provide
for the management thereof.

WHEREAS the Council of the Town of Pelham deems it necessary to
increase the water rates to those buildings which are furnished with water by
the Town of Pelham;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF
PELHAM ENACTS AS FOLLOWS:

- (1) THAT Schedule "A" to By-law #535 (1979) be amended by changing
the basic water rate from \$3.40 per month to \$3.75 per month.
- (2) THAT Schedule "A" to By-law #535 (1979) be amended by changing
the overage charge from \$.90 per 4.56M³ to \$1.00 per 4.56M³.
- (3) THAT Schedule "A" to By-law #535 (1979) be amended by changing
the charge for a minimum bill from \$3.40 to \$3.75.
- (4) THAT Schedule "A" to By-law #535 (1979) be amended by changing
the charge to water loading stations from \$1.02 per 4.56M³ to \$1.13 per 4.56M³.
- (5) THAT Schedule "B" to By-law #535 (1979) be amended by changing
the charges for installation of a 19.1mm service from \$325.00 to \$32.81 per
metre; for installation of a 25.4mm service from \$350.00 flat rate to \$49.21
per metre; for installation of over 25.4mm service to 50.8mm from \$500.00
deposit to \$800.00 deposit.
- (6) THAT Schedule "C" to By-law #535 (1979) be amended by changing
the charges for water meters, remote readers and meter testing, as follows:
 1. (a) 15.9mm - From \$75.00 to \$90.00
 - (b) 19.1mm - From \$100.00 to \$135.00
 - (c) 25.4mm - From \$130.00 to \$180.00
 - (d) 38.1mm - From \$225.00 to \$375.00
 - (e) 50.8mm - From \$325.00 to \$475.00
 2. (a) Remote readers with installation by homeowner -
From \$25.00 to \$30.00
 - (b) Supply of remote readers with installation by Town -
From \$60.00 to \$72.00

3. (a) Charge for testing meter at owners request changed from \$15.00 to \$25.00
