

THE CORPORATION OF THE
T O W N O F P E L H A M
BY-LAW #709 (1981)

Being a by-law to change the names of
certain streets in the Town of Pelham

WHEREAS paragraph 97 of Subsection 1 of Section 354 of
The Municipal Act, R.S.O. 1970, Chapter 284, as amended, provides that
by-laws may be passed by the Councils of local municipalities for
changing the names of highways;

AND WHEREAS the Council of the Town of Pelham deems
it desirable and necessary to change the names of certain streets in
the Town of Pelham;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE
TOWN OF PELHAM ENACTS AS FOLLOWS:

(1) THAT the name of Canboro Road in the Town of Pelham, in
the Regional Municipality of Niagara, in the Village of Fonthill, and
being composed of that portion of Canboro Road as shown on Plan 25, now
known as Plan 717, and more particularly described as follows:

COMMENCING in the easterly limits of the Village of
Fonthill at a point where Canboro Road intersects the eastern boundary
of former Township of Thorold Lot No. 167 as shown on Plan 25, now 717,
for the Village of Fonthill;

THENCE following the centre line of Canboro Road in a
westerly direction through said Lot 167 to Station Street;

THENCE continuing in a westerly direction through former
Township of Thorold Lot No. 168 and bounded on the south by Lots 39 to 34,
both inclusive, and bounded on the north by Lots 7 to 1, both inclusive,
and lots 42, 43, 44, all as shown on Plan 25, now 717, to Pelham Street,
be hereby changed to Highway #20 East.

(2) THAT the name of Canboro Road in the Town of Pelham, in
the Regional Municipality of Niagara in the Village of Fonthill, and being
composed of that portion of Canboro Road as shown on Plan 25, now known
as Plan 717, and more particularly described as follows:

COMMENCING at the southwest angle of Lot 44, as shown
on Plan 25, now 717, for the Village of Fonthill, and the northwest angle
of Lot 34, Plan 25, now 717, for the Village of Fonthill, which is the
easterly point of intersection of Canboro Road and Pelham Street in
the said Village of Fonthill;

THENCE continuing in a westerly direction and bounded
on the north by Lots 54 to 59, both inclusive to the southwest corner

of Lot 59, and bounded on the south by Lots 1 through 4, both inclusive to the northwest corner of Lot 4, all as shown on Plan 25, now 717, which point is the intersection of Canboro Road with Church Street in the said Village of Fonthill, be hereby changed to Highway #20 West.

(3) THAT the name of Church Street, in the Town of Pelham, in the Regional Municipality of Niagara, and in the Village of Fonthill, and being composed in part of that portion of Church Street as shown as Part 1 on Order-in-Council registered as No. 128285, said Part 1 being parts of Lots 60, 61, 63, 64, 65, 66 and 67 and parts of Blocks H, I, J, T and S, all according to registered Plan 25, now known as 717, for the Village of Fonthill, and more particularly described as follows:

COMMENCING at the southwest angle of Lot 59, as shown on Plan 25, now 717, and the northwest angle of Lot 4, Plan 25, now 717, for the Village of Fonthill, which is the easterly point of intersection of Canboro Road and Church Street in the said Village of Fonthill;

THENCE in a westerly direction following the centre line of Church Street and bounded on the north by the Village of Fonthill Park lands in Block H, and Blocks I, J, T and S, as shown on Plan 25, now 717, and the lands shown on registered Plan 28, now 720 and registered Plan 26, now 713, and bounded on the south by Lots 63 to 67, both inclusive, and lots 84 to 91, both inclusive, as shown on Plan 25, now 717, to Haist Street;

THENCE continuing in a westerly direction bounded on the north by Lot 3, Commission 7 to the southwest corner of Lot 3, in the former Township of Pelham, and on the south by Lots 115, 116, Blocks X and Y to the northwest corner of Block Y as shown on Plan 25, now 717, to Lookout Street, which is the westerly limit of Church Street in the said Village of Fonthill, be hereby changed to Highway #20 West.

(4) THAT this by-law shall come into force and effect upon the registration of the by-law in the Registry Office for the Registry Division of Niagara South.
