NOTICE OF APPLICATION to the
Ontario Municipal Board by
the Corporation of the Town
of Pelham for approval of a
by-law to regulate land use
passed pursuant to Section
39 of The Planning Act.

TAKE NOTICE THAT the Council of the Corporation of the Town of Pelham intends to apply to the Ontario Municipal Board pursuant to the provisions of Section 39 of The Planning Act for approval of By-law #731 (1981) passed on the 2nd., day of November, 1981. A copy of the by-law is furnished herewith and a note giving an explanation of the purpose and effect of the by-law and stating the lands affected thereby is also furnished herewith.

ANY PERSON INTERESTED MAY, within twenty-one (21) days after the date of this notice, send by registered mail or deliver to the Clerk of the Town of Pelham, notice of objection to approval of the said by-law or part thereof giving details of all or the portion of the by-law to which you object and detailed reasons therefor, and shall indicate that if a hearing is held the objector or agent will attend at the hearing to support the objection.

ANY PERSON wishing to support the application for approval of the by-law may within twenty-one (21) days after the date of this notice send by registered mail or deliver to the Clerk of the Town of Pelham notice of his support of approval of the said by-law together with a request for notice of any hearing that may be held giving also the name and address to which such notice should be given.

THE ONTARIO MUNICIPAL BOARD may approve of the said by-law, but before doing so it may appoint a time and place when any objection to the by-law will be considered. Notice of any hearing that may be held will be given only to persons who have filed an objection or notice of support and who have left with or delivered to the Clerk undersigned, the address to which notice of hearing is to be sent out, similarly, to any person who has filed a request for a change in the provisions of the by-law.

THE LAST DATE FOR FILING OBJECTIONS will be DECEMBER 4th., , 1981
