#### THE CORPORATION OF THE OF PELHAM TOWN BY-LAW #782 (1982)

Being a by-law to amend By-law #352 (1976), as amended, of the Corporation of the Town of Pelham with respect to the Tariff of Fees in the Fonthill and Hillside Cemeteries and the Fonthill Mausoleum.

WHEREAS Section 65, Subsections (b), (c), (d) and (e) of the Cemeteries Act, R.S.O. 1980, Chapter 59, as amended, permit, subject to Sections 5-61 and to the regulations under The Cemeteries Act, that the Council of every local municipality may regulate funerals and the interment of the dead; acquire land in the municipality for cemeteries or for the enlargement of existing cemeteries, of which the municipality is the owner; or the selling or leasing parts of such land for the purpose of interment of the dead or otherwise fixing the terms in which the land should be leased and held; and for maintenance, management, regulation and control of any cemetery that is owned by the Corporation in the municipality;

AND WHEREAS the Corporation of the Town of Pelham is the owner of the Fonthill Cemetery and Hillside Cemetery and the Fonthill Mausoleum;

AND WHEREAS Council of the Corporation of the Town of Pelham deems it necessary to amend the present Tariff of Fees;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

- THAT By-law #352 (1976) be and is hereby amended by deleting Schedule "A" to By-law #352 (1976) and substituting Schedule "A" attached hereto and forming part of this by-law in its place.
- (2) THAT this by-law shall come into force whon being passed by Council of the Corporation of the Town of Pelham and upon being approved by the Ministry of Consumer & Commercial Relations.
