

THE CORPORATION OF THE
T O W N O F P E L H A M
BY-LAW #790 (1982)

Being a by-law to amend By-law #535 (1979, as amended, being a by-law to regulate and govern the installation of watermains, water services, water meters and remote readers in all areas of the Town of Pelham, and to fix rates and charges for the installation of same and for the water thereby supplied, and to provide for the management thereof.

WHEREAS the Council of the Town of Pelham deems it necessary to increase the water rates to those buildings which are furnished with water by the Town of Pelham;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

(1) THAT Schedule "B" to By-law #535 (1979) be amended by deleting Section 1 - Installation of Service Pipes and substituting the following in its place:

"The cost of installing each water service from the watermain in or under any highway (and whether under Provincial, Regional or Town jurisdiction) to the limits of the private property abutting such highway shall be as follows:

For a 19.1mm (3/4") service - \$98.50 per metre

For a 25.4mm (1") service - \$105.00 per metre

For a 38.1mm (1½") service - actual costs with \$1,000 deposit

For a 50.8mm (2") service - actual costs with \$1,200 deposit

For any service above 25.4mm (1 inch), the owner will receive a refund of the actual cost of the service is less than the deposit.

(2) THAT Schedule "C" to By-law #535 (1979) be amended by deleting Sections 1 and 2 in their entirety and substituting the following:

"1. New Water Meters & Remote Readers -

The capital contribution to the Town for water meters and remote readers with the Town retaining ownership shall be as follows:

(a) 15.9mm (5/8") - \$100.00 Flat Rate

(meter with remote control M³)

(installed by homeowner or homeowners agent)

(b) 19.05mm (3/4") - \$100.00 Flat Rate

(c) 25.4mm (1") - \$130.00 Flat Rate

(d) 38.1mm (1½") - \$225.00 Deposit

(e) 50.8mm (2") - \$325.00 Deposit

2. Remote Readers -

(a) Supply rebuilt water meter with installation of the new type of meter by Town forces with homeowner installing remote control and wire for above noted meter \$33.00.

(b) Rebuilt meter, remote control and wire installed by Town \$80.00."

For all other meters, a deposit will be made equal to the estimated capital cost of the meter with the final cost to be calculated on a cost plus basis taking into consideration material, labour, equipment and 10% overhead."
