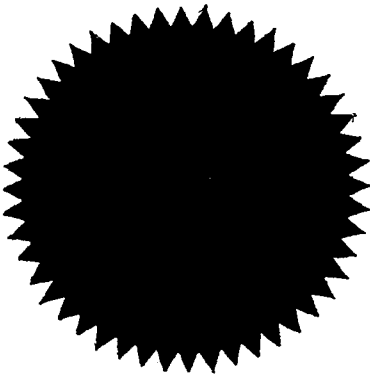
**THE BOARD ORDERS that this application be granted and the

work commenced or commitment made until ten days after a by-law**


