

THE CORPORATION OF THE

BY-LAW #899 (1983)

Being a by-law to amend By-law #646 (1980), a
by-law to provide for licensing and regulating
the keeping of dogs.

WHEREAS the Council of the Corporation of the Town of Pelham
deems it necessary and desirable to amend By-law #646 (1980), being a by-law
to provide for licensing and regulating the keeping of dogs;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF
PELHAM ENACTS AS FOLLOWS:

(1) THAT Section (1) of By-law #646 (1980) be amended by the
addition of the following: -

(1) "Additional Dog" - means more than one dog kept or
harboured on one property save and except multiple residential
units.

(2) THAT Section (2) (a) of By-law #646 (1980) be amended by
substituting the words "last day of February" for the words "30th. day of
June."

(3) THAT Section (2) (c) of By-law #646 (1980) be deleted in its
entirety and the following added in its place: -

(c) The annual licence fee payable, by the owner, to the
Treasurer of the Corporation, or such other person or
organization as is authorized, from time to time, by the
Council of the Corporation of the Town of Pelham, shall be as
follows: -

Fees For Dog Licences Purchased prior to the Last Day of
February -

\$7.00 for a spayed or neutered dog (upon the production of a
certificate, in writing, of a veterinary surgeon that
the dog, male or female, has been spayed or neutered)
\$10.00 for each additional spayed or neutered dog
\$10.00 for a male dog, if only one is kept
\$15.00 for each additional male dog
\$15.00 for a female dog, if only one is kept
\$20.00 for each additional female dog

Fees for Dog Licences Purchased After the Last Day of February

\$9.00 for a spayed or neutered dog (upon the production of a certificate, in writing, of a veterinary surgeon that the dog, male or female, has been spayed or neutered)
\$12.00 for each additional spayed or neutered dog
\$12.00 for a male dog, if only one is kept
\$17.00 for each additional male dog
\$17.00 for a female dog, if only one is kept
\$22.00 for each additional female dog


(4) THAT Section (2) (e) of By-law #646 (1980) be amended by the addition of the following after "issued" "except in the case where the dog, for which the original tag was procured, becomes deceased. If the owner of the deceased dog obtains another dog within the calendar year for which the original tag was issued, that tag may be attached to the new dog."

(5) THAT Section (3) of By-law #646 (1980) be amended by deleting "January" on line one and adding "December" in its place.

(6) THAT Section (4) of By-law #646 (1980) be deleted in its entirety and the following added in its place: -

"4. Every dog owner who takes up residence in the Town of Pelham throughout the course of any year and who has possession of a dog licence, issued by the municipality in which he formerly resided, for each dog in his possession, shall report the dog licence number, municipality where obtained and type of dog to the Treasurer but shall not be required to obtain a dog licence from the Town of Pelham until the next calendar year following the year of initial residence in the Town of Pelham."
