IN THE MATTER OF Section 64 of The Ontario Municipal Board Act, (R.S.O. 1980, c. 347), and

Section 12 of The Local Improvement Act, (R.S.O. 1980, c. 250)

### - and -

IN THE MATTER OF an application by The Corporation of the Town of Pelham for an order approving:

- (a) the construction of a local improvement described in Schedule "A" thereto, at an estimated cost not exceeding \$19,440.00, and the borrowing of money by way of temporary advances not exceeding in the aggregate such estimated cost pending the sale of debentures, and
- (b) the issuance of debentures therefor in the sum of \$19,440.00, by The Regional Municipality of Niagara for a term not to exceed ten years, chargeable to the applicant corporation

such application having been approved by order of the Board dated the 8th day of December, 1983

#### - and -

IN THE MATTER OF a present application for an order approving:

- (c) an additional expenditure of \$5,560.00 covering an additional estimated cost of this amount, and the borrowing of money by of temporary advances not exceeding in the aggregate such additional estimated cost pending the sale of debentures,
- (d) the issuance of additional debentures in the amount of \$4,060.00 by The Regional Municipality of Niagara, chargeable to the applicant corporation, and
- (e) an amendment to the previous order of the Board by replacing Schedule "A" thereto with Schedule "A" hereto

THE BOARD ORDERS that this application be granted and the total expenditures and the total debentures to be issued under this order and under the previous order of the Board dated the 8th day of December, 1983, and entered in order book No. E 83-3 at folio 341 on the 28th day of December, 1983, are not to exceed expenditures of \$25,000.00 and debentures of \$23,500.00, for a term not exceeding the term prescribed in such previous order and additional rates to be considered by the Court of Revision; and provided that the corporation and the council of such regional municipality in exercising any power approved by this order shall comply and conform with all statutory and other legal requirements related thereto;

AND THE BOARD ORDERS that its previous order is hereby amended by replacing Schedule "A" thereto, with Schedule "A" hereto, annexed and signed by the Secretary.


