THE CORPORATION OF THE TOWN O F PELHAM

BY-LAW NO. 907 (1984)

Being a by-law to authorize the construction of a watermain, laterals and hydrant on Balfour Street from Welland Avenue to a point approximately 230 metres north of Welland Avenue as a Local Improvement.

WHEREAS the Council of the Corporation of the Town of Pelham deems it desirable to undertake the construction of a watermain, laterals and hydrant on Balfour Street from Welland Avenue to a point approximately 230 metres north of Welland Avenue, as set out in Schedule "A" annexed hereto as a local improvement under the provisions of the Local Improvement Act, at an estimated cost of \$25,000.00;

AND WHEREAS the notice required by Section 12 of the said Act with respect to the construction of a watermain, laterals and hydrant on Balfour Street from Welland Avenue to a point approximately 230 metres north of Welland Avenue, was published in The Pelham Herald on the 25th. day of October, 1983;

AND WHEREAS the Ontario Municipal Board has approved the construction of the said works as appears by its Order on File No. E 831285 dated the 12th. day of January, 1984;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

- THAT the construction of a watermain, laterals and hydrant on Balfour Street from Welland Avenue to a point approximately 230 metres north of Welland Avenue, as set out in Schedule "A" annexed hereto, as a local improvement under the provisions of the Local Improvement Act, at an estimated cost of \$25,000.00 be and the same is hereby approved and authorized.
- THAT except as to that portion of the cost of the said work which is to be borne by the Corporation in accordance with the provisions of the Local Improvement Act, the cost of the said works shall be specially assessed against the lands abutting directly on the said works and the special assessments to be made in respect thereof shall be made in ten equal annual installments by an equal special rate per metre frontage of such lands.
- THAT the Mayor and Treasurer are hereby authorized on behalf of the Corporation to borrow from any person, firm or corporation from time to time, pending the issue and sale of debentures by the Regional Municipality of Niagara, any money necessary to meet the expenditures incurred in constructing the said works up to the amount shown in Schedule "A" as the estimated cost thereof, and the Mayor and Treasurer are hereby authorized to execute a promissory note or notes therefor and the Clerk is hereby authorized to affix the Corporate Seal thereto.
